#### 1. Chair's welcome

#### 5. **Proposals**

### (a) Fixed Venue for the Competitive Summer League

The proposal had been circulated ahead of the meeting for teams to discuss with their members. It was then discussed with various view points put forward before a vote.

The voting was :-

To change to the proposal of central venue - 11

To stay as at present – 20

Abstentions - 3

The Competitive Summer League will therefore continue in its present form.

### (b) Amendments to the Play-up Rule

Keep one play-up per person with a maximum of two players per game, or

Two opportunities for each player to play up, once before mid-season point and once after with a maximum of two playing up per game.

The members voted unanimously to allow two opportunities for each player to play up.

### (c) Amendment to the Constitution

Amendment to allow the Committee to adapt the Handbook as and when necessary without the need for change to be voted on at Annual General Meeting. It was made clear to members that the Committee would only make changes for the smooth running of the League and for the benefit of all teams. These would be small changes that might occur during the year.

The voting was :-

For the proposal – 22

Against 7,

Abstentions – 4.

The motion was therefore carried.

### 6. **Donations**

#### (a) Victoria Hawkins Memorial Tournament.

Members were asked to agree that the League continue to pay the cost of the courts for this tournament. (£330 in 2022).

Proposal agreed unanimously.

#### (b) Junior League

Members were asked to agree to continue to assist the juniors with a donation of £400.00. Sophie Pike queried why the donation of £400 agreed at 2021 AGM had not been cashed. It was explained that the Junior League were changing bank accounts and this has only just been done.

Proposal therefore carried unanimously
